GENERAL GUIDELINES	Manuscripts should be COMPLETE, CONCISE and CLEAR (See <u>EASE</u> <u>Guidelines</u> , available in many languages).	
	Follow the appropriate reporting guidelines where applicable.	
WORD LIMITS, etc.		
Body Text	InterPore Journal currently does not have any limits set for any of the article types. Instead, we will currently leave this up to the Reviewers and Editor to comment upon should they feel that the text is overly long or wordy.	
Abstract	The abstract should be no longer than 1 page of text. A graphical abstract may also be included with the text if this helps in conveying the message of your work.	
	An abstract is not required for the following types of articles: Commentaries on Previously Published Articles, Letters to the Editor, and Opinion Pieces.	
Keywords	At least three and ideally, no more than five keywords should be provided. A keyword can also be a phrase composed of multiple words.	
Highlights / Key Message	We currently do not require this; it is the authors decision to include this as a text box in their paper if they would like to.	
Tables / Figures	There is currently no limit on the number of tables and/or figures one should include. This will be left up to the Reviewers and assigned Editor to comment upon if they feel it is too many. Color should however be used when possible.

Short Running Title	None needed as this will be done by the Editorial Office during the production stage if your paper is accepted.
